### New entry of foreign nationals

(2) Foreign nationals newly entering Japan for a short-term stay for tourism (only when a travel agency among others organizing the trip serves as the receiving organization of the entrants)

\* New entry of foreign nationals into Japan for a short-term stay for tourism based on the category (2) above has been limited to those who will enter from the countries/regions classified as Blue.

Meanwhile, from September 7, 2022, based on the New Border Measures (32), the measure will apply to those who will enter from all countries/regions. The measure will also apply to such cases as group tours without a tour conductor.

- (1) New entry for a short stay (less than 3 months) for the purpose of business, employment, etc.
- (2) New entry for a short stay (less than 3 months) for the purpose of tourism. (Only when a travel agency, etc. is responsible for receiving the applicant.)
- (3) New entry for long-term stay

※New entry of foreign nationals into Japan for a short-term stay for tourism based on the category (2) above has been limited to those who will enter from the countries/regions classified as Blue. Meanwhile, from September 7, 2022, based on the New Border Measures (32), the measure will apply to those who will enter from all countries/regions. The measure will also apply to such cases as group tours without a tour conductor
